

Subject: Request for Concessionary Tariff Rate on Supply of Electricity and Gas.

I am directed to refer to the subject and to say that Federal Board of Revenue, vide circular No. 04 of 2020 dated 30.12.2020 has devised mechanism for enrollment of Registered Persons under the export-oriented sectors (erstwhile zero-rated sectors) to qualify concessionary regime of electricity, RLNG and Gas tariff in the light of decision of Economic Coordination Committee (ECC) of the Cabinet in case No.ECC-434/59/2020 dated 02.12.2020.

2. Accordingly, Pakistan Textile Exporters Association (PTEA) has forwarded case of M/s Sadaqat limited duly recommend for grant of concessionary tariff rate on supply of gas and electricity. The application of taxpayer was verified with the data available with FBR and as recommended by the PTEA, the case is forwarded for allowing concessionary rate-tariff through respective DISCO/Gas Company on utility connections. 


